I confirm, that my birth date and all further given information are valid. I assure, that I won't pass my start authorization to another person. The participant has to legitimize himself at the collection of the starting documents by a valid identification card or passport, completed by a signed version of the exclusion of liability. The organizer takes no liability for the loss of the wardrobe and any valuables. The organizer is not liable for the correctness of data of the jury's judgement. The organizer is entitled to make amendments regarding the event, at any time. These amendments do not justify any claim of damages of the participant, at all. With my signature, I affirm that I join the event on my own responsibility and on my own risk.

EXCLUSION OF LIABILITY

In addition, I affirm, that in case of impairments I won't have any claim against the organizer, the ground proprietor, against the authorities that have a relation with the event, against other participants and that I have insurance regarding accidents, sufficiently, and that I hold a liability insurance. The exclusion of liability includes all claims of any legal cause, especially for claims of damages resulting both from contractual and non-contractual liability and also for claims resulting from unauthorized actions.

The organizer is not liable for personal, material and pecuniary damages, as well as ordinary negligence. This applies for own actions as well as actions of substitutes, agents or another third party the organizer employs related to the event.

Only claims resulting from an intentional or negligent violation of duty of the category of persons mentioned before are exempted from the exclusion of liability. The organizer is not liable for any health risks and dangers of the participant. There are no liabilities to pay compensation for the organizer against the participant, because of acts of nature, regulatory actions or because of safety reasons that obliges the organizer to undertake rearrangements of the event or to cancel it.

STATEMENT OF AGREEMENT

I agree that all photographs, film exposures and interviews related to the event can be used, distributed and published within the world-wide web, television, broadcast, books, commercials, movies, videocassettes, DVDs, etc. without claims for compensation of myself. I agree, that my full name will be published within lists of results and for the purposes of reporting. I agree that my data (full name, address and picture) is allowed to be shared with sponsors, the official photographers and other events that are listed in the event's programme for advertising and information purposes. Hence, I agree that even against my will, the event staff and paramedics are allowed to exclude me from the competition for different reasons they consider necessary (especially for sanitary and/or safety reasons). The organizer is not liable for any health risks and dangers of the participant. It is the participant's responsibility to reconsider his physical condition before the participation of the event and to get a medical confirmation, if necessary. There are no liabilities to pay compensation for the organizer against the participant, because of acts of nature, regulatory actions or because of safety reasons that obliges the organizer to undertake rearrangements of the event or to cancel it.

FINAL CLAUSES

In case single clauses of the general starting conditions, the exclusion of liability or statement of agreement are void, all remaining clauses are unaffected. By entering the event building and the participation of the event "National & International Calisthenics Championship", I accept the contents of the general starting conditions, the exclusion of liability and the statement of agreement. I read the whole text carefully, understood it completely, which is confirmed by my signature. This form will only become valid in combination with a copy of an official photo identification.
